Ha curato l'*Handbook of Anticipation* (Springer 2019), la più ampia rassegna mai pubblicata sui diversi modi in cui scienze, discipline e comunità di pratica usano il futuro, e pubblicato sia in italiano che in inglese una introduzione agli studi di futuro, (It: *Lavorare con il futuro. Idee e strumenti per governare l'incertezza* (Egea 2019)). Complessivamente ha pubblicato oltre 250 articoli scientifici e otto libri. Sta curando l'*Handbook of Futures Studies*, che verrà pubblicato da Elgar nel 2024.
