The purpose of these notes is to facilitate the Authors in the presentation of their work and to optimize the sending/revision/publication procedures. Scientific papers must strictly conform, upon nonacceptance, to the indications contained in the editorial rules and available at: www.difesa.it/GiornaleMedi-<u>cina/rivista/Pagine/Norme\_Redazionali.</u> aspx. These indications have been drawn up in compliance with the provisions regarding "Protection of copyright and other rights connected to its exercise" (Law of 22 April 1941, n. 633).

The Authors of the papers, by accepting the conditions of the rules, grant to "Giornale di Medicina Militare", free of charge, the right to economic use of the intellectual work/s, whose intellectual property remains with the Author and with the limitations arising from the attribution of the aforementioned right of publication.

The papers intended for publication must comply with the constraints of the Code regarding the protection of personal data (Legislative Decree of 30 June, n. 196) as well as those arising from the legislation on State Secrets and those relating to the prohibition of publishing confidential/controlled/classified information in the NATO-UEO and/or national context. Collaboration is open to all Authors who enjoy civil and political rights in the State

of belonging or origin.

The responsibility for the actual ownership of such rights falls within the personal sphere of the Author who declares to be in possession of them.

The editorial products intended for publication must be unpublished and free from editorial constraints.

To this end, the Authors must sign and forward together with the article a specific declaration in lieu of certification and declaration of conflicts of interest (Disclosures) available online at the link <a href="https://www.difesa.it/GiornaleMedicina/rivista/Pagine/Norme Redazionali.aspx">www.difesa.it/GiornaleMedicina/rivista/Pagine/Norme Redazionali.aspx</a>

The Journal publishes scientific works, scientific communications/clinical cases/short notes, editorials (by invitation only) and any other relevant scientific or military contribution. In this regard, the online section Instructions for Authors can be consulted at the following link https://www.difesa.it/giornalemedicina/rivista/norme-redazionali/26694.html

Acceptance of the article is subject to the opinion of the Scientific Committee and the Board of Reviewers, with relative written communication within one month of receipt (Law 633/1941, Art.39). Scientific articles, such as original studies, reviews, case reports, perspectives, are subjected, after acceptance, to a single-blind peer review process entrusted to the competent members of the Board of Reviewers. This process ends within 6 months with the relative communication to the author by the Director and/or Editor-in-Chief of a request for modification, publication or rejection of the scientific article. It should be noted that all accepted works are bound for 12 months. Furthermore, the Scientific Committee in the peer review process may further avail itself of the opinion of the competent bodies of the Armed Forces regarding the opportunity to publish an article or not.

In order to shorten publication times, it is recommended to send the paper already accompanied by the favorable opinion of the hierarchical Superiors.

A preferential condition for the publication of the works is that at least one of the Authors is a member of the Health Services of the Armed Forces, GdF, State Police or, alternatively, of the C.R.I., the S.M.O.M., the VV.FF. or to the Civil Protection.

It is specified that all Authors must comply with the rules set out in the Code of Ethics and are responsible for the scientific content of the text, as well as that it has not already been published or simultaneously sent to other journals for publication. The works become the property of the Journal and cannot be published in whole or in part elsewhere without the permission of the Publisher.

It is required to send a short curriculum vitae and the contact details of all the Authors and the Author in charge of the paper (address, tel., fax, e-mail).

The works, photos and computer media will remain in the archives of the Editorial Office, not returned even if not published. The submission of the papers implies the observance by the Author, without any reservation, of all the rules, conditions and constraints referred to in these rules, as well as the presentation of the declarations at the same time as the paper and failure to comply will result in automatic exclusion from the procedure. For anything not expressly provided for in this Regulation, reference is made to the rules dictated by the legislation on the matter and subsequent/related legislative and/or regulatory provisions.

Pursuant to EU Regulation 2016/679 and Legislative Decree 2018/101, we inform you that the personal data provided by the Authors will be used exclusively for the completion of the procedure in question. In particular, the Author may exercise the right to access personal data, request correction, integration, or any other right contemplated by the aforementioned decree.

Pursuant to art. 71 of the Presidential Decree of 28 December 2000, n. 445, the Administration has the right to carry out suitable checks, including random checks, as well as in all cases where doubts arise regarding the veracity of the self-certification declaration made for the purposes of participation in the evaluation for the publication of the documents.
