WiFi TERMS AND CONDITIONS

This document sets out the terms and conditions on which wireless internet access is provided to you.

THE SERVICE

DURATION OF SERVICE AND EFFECTIVENESS OF THE AGREEMENT

1. This agreement is valid for the period required by the date on which the User first use the WiFi Service.
2. The ItaJAOS reserves the right to suspend and/or interrupt and/or vary, at any time and without notice the WiFi Service and can not be considered responsible for both the User and third parties for the interruption. In this case, all rights of the User to use the WiFi Service will immediately cease.

3. The ItaJAOS may, at its sole discretion, modify and/or amend at any time and without notice, the terms and conditions of this Agreement.

RESPONSIBILITIES OF THE PROVIDER

1. The ItaJAOS assumes no responsibility for any alterations or interference with a computing device's configuration, operation or data files resulting from connection to the WiFi network. We do not guarantee that any services are error or virus free;
2. The ItaJAOS has no responsibility for, or control over, the information you transmit or receive via this connection;
3. The ItaJAOS does not guarantee the availability of the connection, the speed at which information may be transmitted or received via the connection or that the connection will be compatible with your equipment or any software which you use;
4. The ItaJAOS takes reasonable steps to ensure the security of the connection and we confirm that we will use the registration data you provide to us exclusively for institutional purposes.
