The SQF-MILOF serves as an interface or 'translation tool' between the education and training opportunities offered in different countries, which makes it possible to compare different programmes.

The SQF-MILOF was developed by a working group, whose role was to create a community of interest, consolidate and discuss national input, ensure national issues were integrated into the SQF-MILOF, and define descriptors and learning outcomes for all levels of the military officer career.
