**Investigating and Preventing Sexual and Gender Based

1. Conditions of Participation

This course is open to all CSDP personnel (civilian, military and police) - eager to work on gender equality and towards ending impunity for sexual and gender based violence. Although the main target audience is aiming at EU Member State's personnel, the course is also open to relevant personnel from third countries and partner organisations.

Applicants for this training should have a special interest on implementing such trainings in fragile and post conflict settings inside and outside the mission structure.

The course is particularly useful for personnel with an investigating or advisory role with a background in police, judiciary and others areas of experts as well as gender and human rights advisors.



The course language is English and participants must be fully competent in English in order to be able to engage in discussions and fully benefit from the training.

## 2. Selection Criteria and Process

The organizers have formed a Course Admission Board and endeavour to select a highly qualified group of participants in order to ensure the set course standard. The selection process considers a balance in professional and organizational backgrounds, age nationality and gender. Qualified women candidates are strongly encouraged to apply.

Since the number of participants is limited to 16, only the best qualified candidates can be accepted. Successful candidates will be informed after the completed selection process, which will be approximately two weeks after the application deadline. There is no possibility to make a claim for participation.

## 3. Application

For the application, please use the provided „Registration Form“ and fill in all relevant information, particularly an active email address that you have regular access to, as we will be sending you important course-related information. We also need a CV and a brief motivation letter.

#### 4. Costs of Participation

With regards to generous support from the Baden-Wuerttemberg State Police College and the Federal Ministry of the Interior, Building and Community no tuition fees will be due.

The State Police College offers full board and lodging against a reduced fee to be covert by the sending authorities. The total amount for board and lodging is: 495€. No catering will be provided during the weekends.

Please be aware, there is no compensation for travel expenses and there are no scholarships. Participants also cover the visa fees and all other extras such as individually consumed beverages, laundry, telephone bills, taxi costs, and other personal expenses.

Participants are furthermore expected to have a valid full medical and other insurance coverage for their stay in Germany.
